Confidential AAA Arbitration (Phoenix, AZ)

Represented a Fortune 100 company in confidential, multi-billion dollar dispute. The two-week arbitration hearing included testimony from numerous senior executives and expert witnesses. Obtained complete victory for client.

Equal Employment Opportunity Commission v. Texas Roadhouse (D. Mass.) Trial counsel for landmark pattern or practice age discrimination claim brought by EEOC against national restaurant chain. After three-week jury trial in January 2017, case ended in a mistrial because jury was deadlocked after deliberating for one week. Case settled very favorably before retrial.
