In recent years, Alex has served on trial teams for a trade secret jury trial for Hewlett Packard Enterprise related to automated testing software, a bench trial involving equitable claims for unjust enrichment and *quantum meruit* brought by the founder of a group of privately held oil and gas companies, and a public nuisance jury trial for Walgreens as part of nationwide litigation related to the distribution and sale of prescription opioid medications.

Alex has also handled multiple pro bono matters, including successfully representing an asylum seeker fleeing persecution and death threats by a Central American drug cartel and resolving claims for defamation arising in the professional gaming industry.

Opioids Litigation
