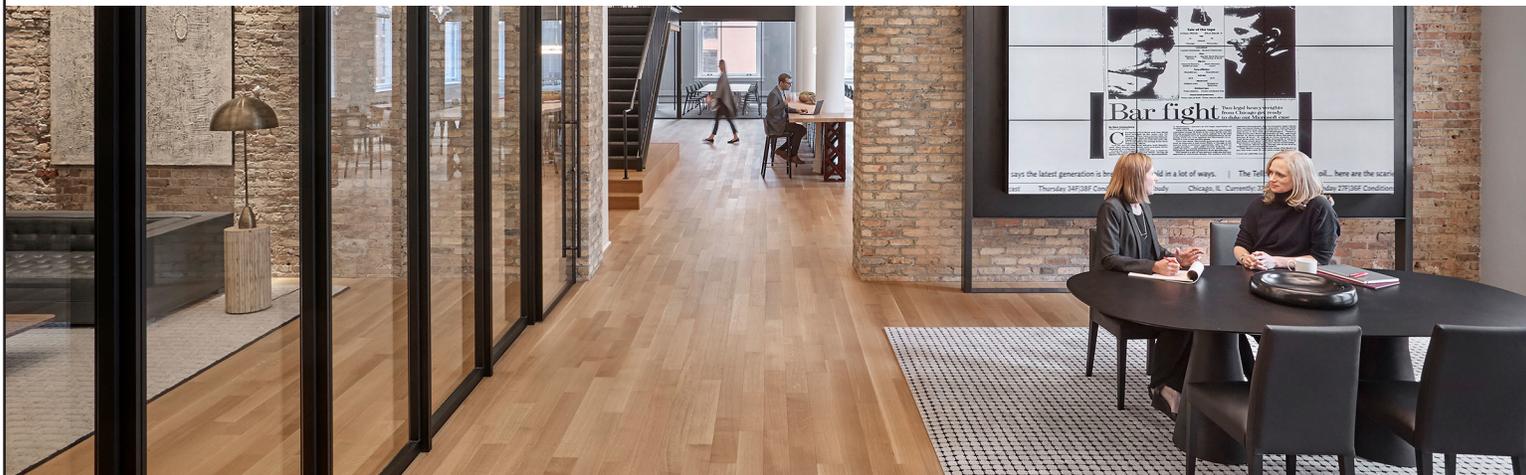

### Chicago Litigation:

**"The Firm:** The firm's brand of litigation has been likened to *'well-aimed nukes in a conflict situation.'* commentators said. One of the most successful litigation specialists nationwide, its concentrated focus on complex courtroom battles draws distinction. With offices in Denver and Chicago, about 35 partners with "unparalleled experience of going to trial" participate in some of the most important cases around."

**"The Lawyers:** Superb Philip Beck *'can blow anyone away,'* observers said. He successfully acted for Residential Funding Corporation in a breach of contract dispute with DeGeorge Financial Corporation; the case resulted in a \$96 million jury verdict in favor of the firm's client. Having created a *'spectacular reputation,'* Fred Bartlit is viewed as a *'trial attorney extraordinaire'* whose expertise successfully combines technical mastery with courtroom finesse. Known as counsel to George Bush in the 2000 presidential election, he has participated in disputes involving patents, products liability, white-collar crime and securities among others. New to the rankings is the *'excellent and hard-working'* Adam Hoeflich, who has defended Bayer in litigation emanating from the withdrawal of Baycol, a cholesterol-lowering drug."
